#6 DISTRICT REPORTS

#6.1 Financial Reports – Ms. Carpenter shared March's financial reports of Accounts Payable, Budget/Actuals report, and General Ledger Cash Balance with the Board.

#6.2 Administrative Reports:

Mr. Eric Milburn shared Ms. Maureen March, Riley Creek School Principal's report: Award assemblies will be April 28th for Kindergarten thru 5th grade and April 29th for 6th thru 8th Grade;

OSAS state testing is currently underway;

8th Grade Class has decided for their promotion ceremony to have a drive through ceremony; Outdoor school for 6th grade class will be hosted by Camp Fire Wilani May 25th – May 27th; and Currently working with OSU Extension and ASCEND as community partnership for planning summer programs.

Ms. Dana Newdall, Gold Beach High School Principal, shared

Career Fair was a very successful event and a big thank you to Michele Fritch for coordinating the event;

Seniors are very busy with their scholarship applications and preparing for Senior Project Night on May 12th;

Red Cross Blood Drive will be April 27th;

Prom is May 7th;

Savanna Peck's senior project, Drunk Driving Assembly with Gold Beach Fire Department will be May 5th;

<u>Athletics</u>: Spring sports are in full swing with Baseball, Softball & Track; and <u>Plans</u>: Currently advertising for a $6^{th} - 12^{th}$ math teacher; plan to offer an Advanced Biology class for next year, advertising for full time counselor for next year and plan to implement a golf team next year to Spring Sports.

#6.3 Superintendent Report:

Mr. Eric Milburn, Superintendent, shared with the Board the enrollment numbers for the district;

OSSA conference is April 21st & 22nd and Ms. March & Ms. Newdall will also be attending the conference;

Summer School enrichment classes will be available for grades K-8th and credit recovery/Freshman on track classes at the high school;

Currently working with Brookings Harbor High School to share a School Based Health Center (SBHC) with Coast Community Health to help sponsor. With the health services, a reproductive prevention services will need to be offered as well as other medical services. The service will be available for students only and could be available in a trailer with exam rooms on site at the school. Mr. Milburn asked the Board if they supported continuing research on SBHC and the potential costs. The Board supported Mr. Milburn to continue the research for the School Based Health Center and potential costs;

On April 27th the administration will be at SCESD for ODE Integrated Initiative regarding guidance on six aligned programs High School Success(HSS); Student Investment Account (SIA); Student Success Act (SSA), Continuous Improvement Planning (CIP)2, Career & Technical Education – Perkins V (CTE), Every Day Matters (EDM) and Early Indicator Intervention Systems (EIIS); and

The Long Range Facility Planning committee met with Soderstrom Architects on April 18th to discuss further ideas for improving the facilities at Central Curry School District.
